### **Statement of Policy on Pension Discretions**

#### 1. General principles

- 1.1 Compass Contract Services (UK) Ltd is a participating employer in the Local Government Pension Scheme (LGPS) and is required to formulate, publish and keep under review a Statement of Policy on certain discretions which they have the power to exercise in relation to members of the LGPS.
- 1.2 The approach to exercising discretion is to allow Compass Contract Services (UK) Ltd to make a reasonable decision in individual cases, but, also to be clear as to the factors it will take into account in making the decision.
- 1.3 In formulating and reviewing its policy statement Compass Contract Services (UK) Ltd is required to:
  - Have regard to the extent to which the exercise of its discretionary powers, unless properly limited, could lead to a serious loss of confidence in the public service; and
  - Be satisfied that the policy is workable, affordable and reasonable having regard to the foreseeable cost.
- 1.4 Where reference is made in this policy to the decision making role of the Finance Director and/or the Pensions Manager, the authority to make such decisions will belong to the person (s) holding that post / those posts and/or any successor roles should there be a change in the future, which are in place at the time that the Discretion is exercised. Such authority will also extend to any individual person or post or group of individuals and posts as shall be delegated in writing by the Finance Director and/or the Pensions Manager respectively.
- 1.5 Any complaints relating to Compass Contract Services (UK) Ltd's decisions in these matters would need initially to be raised under the Compass Contract Services (UK) Ltd's Internal Dispute Resolution Procedure as set out in the Appendix to this Discretions Policy.

# 2. Discretions from 1 April 2014 in relation to post 31 March 2014 active members and post 31 March 2013 leavers

#### 2.1 What is the Discretion being considered:

Whether, how much, and in what circumstances to contribute to a Shared Cost Additional Voluntary Contribution (SCAVC) arrangement entered into on or after 1 April 2014 [regulation 17 of the LGPS Regulations 2013] and whether, how much, and in what circumstances to continue to contribute to any Shared Cost Additional Voluntary Contribution (SCAVC) arrangement that the employer had entered into before 1 April 2014 [regulation 15(1)(d) of the LGPS (Transitional Provisions, Savings and Amendment) Regulations 2014, regulation 25(3) of the LGPS (Administration) Regulations 2008 and regulations 2007]

### Compass Contract Services (UK) Ltd's policy statement on the circumstances in which it will exercise this discretion:

Where there is a clear and significant financial or operational advantage to be gained by Compass Contract Services (UK) Ltd), Compass Contract Services (UK) Ltd will consider contributing to a SCAVC entered into on or after 1 April 2014 or whether, how much, and in what circumstances to continue to contribute to any SCAVC arrangement that the Scheme Employer had entered into before 1 April 2014, and only then with the prior recommendation of Nicholas Corney Pensions Manager.

#### 2.2 What is the Discretion being considered:

Whether to grant extra annual pension of up to £6,500<sup>1</sup> to an active Scheme member within six months of leaving to a member whose employment was terminated on the grounds of redundancy or business efficiency [regulation 31 of the LGPS Regulations 2013]

### Compass Contract Services (UK) Ltd's policy statement on the circumstances in which it will exercise this discretion:

Where there is a clear and significant financial or operational advantage to be gained by Compass Contract Services (UK) Ltd, then Compass Contract Services (UK) Ltd will consider awarding additional pension, and only then with the prior recommendation of Nicholas Corney Pensions Manager

#### 2.3 What is the Discretion being considered:

Whether, where an active Scheme member wishes to purchase extra annual pension of up to £6,500 $^2$  by making Additional Pension Contributions (APCs), to voluntarily contribute towards the cost of purchasing that extra pension via a Shared Cost Additional Pension Contribution (SCAPC) [regulations 16(2)(e) and 16(4)(d) of the LGPS Regulations 2013]

### Compass Contract Services (UK) Ltd's policy statement on the circumstances in which it will exercise this discretion:

Where there is a clear and significant financial or operational advantage to be gained by Compass Contract Services (UK) Ltd, then Compass Contract Services (UK) Ltd will consider voluntarily contributing towards the cost of purchasing extra pension, where an active Scheme member wishes to purchase extra annual pension by making APCs, and only then with the prior recommendation of Nicholas Corney Pensions Manager

#### 2.4 What is the Discretion being considered:

Whether to permit flexible retirement for staff aged 55<sup>3</sup> or over who, with agreement of the employer, reduce their working hours or grade [regulation 30(6) of the LGPS Regulations 2013] and, if so, as part of the agreement to permit flexible retirement

- Whether, in addition to the benefits the member has accrued prior to 1 April
  2008 (which the member must draw), to permit the member to choose to draw
  - All, part or none of the pension benefits they accrued after 31 March 2008 and before 1 April 2014, and/or
  - All, part or none of the pension benefits they accrued after 31 March 2014 [regulations 11(2) and 11(3) of the LGPS (Transitional Provisions, Savings and Amendment) Regulations 2014].

### <u>Compass Contract Services (UK) Ltd's policy statement on the</u> circumstances in which it will exercise this discretion:

Only where there is a clear operational or significant financial advantage for Compass Contract Services (UK) Ltd will a request for early payment of

benefits under flexible retirement rules normally be permitted. This would be for employees aged 55 or over and applicants could incur actuarial reductions on benefits paid.

Decisions regarding early payment of retirement benefits under the flexible benefits rules where there will be a cost to Compass Contract Services UK Ltd are delegated to the Finance Director for Compass Contract Services UK Ltd. Where there is no cost to Compass Contract Services (UK) Ltd this decision is delegated to Nicholas Corney Pensions Manager.

#### 2.5 What is the Discretion being considered:

Whether to waive, in whole or in part, any actuarial reduction which would otherwise be applied to the benefits taken on flexible retirement before Normal Pension Age (NPA)<sup>4</sup> [regulation 3(5) of the LGPS (Transitional Provisions, Savings and Amendment) Regulations 2014, regulation 18)3) of the LGPS (Benefits, Membership and Contributions) Regulations 2007 and regulations 30(6) and 30(8) of the LGPS Regulations 2013]

### <u>Compass Contract Services (UK) Ltd's policy statement on the circumstances in which it will exercise this discretion:</u>

Where there is a clear and significant financial or operational advantage for Compass Contract Services (UK) Ltd, taking all issues into account, then Compass Contract Services (UK) Ltd will consider waiving, in whole or in part, the actuarial reduction on benefits paid in flexible retirement and only with the prior recommendation of Nicholas Corney Pensions Manager.

#### 2.6 What is the Discretion being considered:

Whether to "switch on" the 85 year rule for a member voluntarily drawing benefits on or after age 55 and before age 60 [paragraph 1(2) & 2(2) of Schedule 2 to the LGPS (Transitional Provisions, Savings and Amendment) Regulations 2014].

## Compass Contract Services (UK) Ltd's policy statement on the circumstances in which it will exercise this discretion:

Where there is a clear and significant financial or operational advantage for Compass Contract Services (UK) Ltd, taking all issues into account, Compass Contract Services (UK) Ltd will consider "switching on" the 85 year rule for members who choose to voluntarily draw their benefits on or after 55 and before age 60, and only with the prior recommendation of Nicholas Corney Pensions Manager.

#### 2.7 What is the Discretion being considered:

Whether to waive any actuarial reduction on pre and/or post April 2014 benefits [regulations 3(1), Schedule 2(1) and 2(2) of the LGPS (Transitional Provisions, Savings and Amendment) Regulations 2014 and regulations 30(5) or 30A (5) of the LGPS (Benefits, Membership and Contributions) Regulations 2007]

### <u>Compass Contract Services (UK) Ltd's policy statement on the</u> circumstances in which it will exercise this discretion:

Where there is a clear and significant financial or operational advantage for Compass Contract Services (UK) Ltd, taking all issues into account, Compass Contract Services (UK) Ltd will consider waiving, in whole or in part, the actuarial reduction that would otherwise be applied to benefits accrued after 31 March 2014 but only with the prior recommendation of Nicholas Corney Pensions Manager.

#### 2.8 What is the Discretion being considered:

Whether, with the agreement of the Pension Fund administering authority, to permit a Scheme member to elect to transfer other pension rights into the LGPS if he/she has not made such an election within 12 months of joining the LGPS [regulation 100(6) of the LGPS Regulations 2013]

## <u>Compass Contract Services (UK) Ltd's policy statement on the circumstances in which it will exercise this discretion:</u>

Compass Contract Services (UK) Ltd will normally only consider extending the time limit of 12 months from joining the LGPS for a Scheme member to elect to transfer other pension rights in to the LGPS if there is clear evidence that they had not been informed of, or could not reasonably have known of the time limit. Decisions on the extension of the time limit are delegated to Nicholas Corney Pensions Manager<sup>5</sup>.

#### 2.9 What is the Discretion being considered:

Whether to extend the 12 month time limit within which a Scheme member who has a deferred LGPS benefit in England or Wales following the cessation of employment (or cessation of a concurrent employment) may elect not to

have their deferred benefits aggregated with their new LGPS employment (or ongoing concurrent LGPS employment) if the member has not made an election to retain separate benefits within 12 months of commencing membership of the LGPS in the new employment (or within 12 months of ceasing the concurrent membership) [regulations 22(7) and (8) of the LGPS Regulations 2013]

### Compass Contract Services (UK) Ltd's policy statement on the circumstances in which it will exercise this discretion:

Compass Contract Services (UK) Ltd will normally only consider extending the time limit of 12 months following the cessation of employment (or cessation of a concurrent employment) for a member not to have their deferred benefits aggregated with their new LGPS employment (or ongoing concurrent LGPS employment), if the member has not made an election to retain separate benefits within 12 months of commencing membership of the LGPS in the new employment (or within 12 months of ceasing the concurrent membership), if there is clear evidence that they had not been informed of, or could not reasonably have known of the time limit. Decisions on the extension of the time limit are delegated to Nicholas Corney Pensions Manager.

#### 2.10 What is the Discretion being considered:

How the pension contribution band to which an employee is to be allocated on joining the Scheme, and at each subsequent April, will be determined and the circumstances in which the employer will, in addition to the review each April, review the pension contribution band to which an employee has been allocated following a material change which affects the member's pensionable pay in the Scheme year (1 April to 31 March) [regulations 9 and 10 of the LGPS Regulations 2013]

### Compass Contract Services (UK) Ltd's policy statement on the circumstances in which it will exercise this discretion:

On joining the Scheme Compass Contract Services (UK) Ltd will allocate an employee to the pension contribution band commensurate with his/her annualised first month's contractual pay. This will be reviewed each April and re-banded based on the annualised average last 3 months total pay, re-valuing on the basis of the April pay, if relevant. The contribution band will also be reviewed following any material<sup>6</sup> change in the member's pensionable pay in the Scheme year (1 April to March 31).

## Discretions for Scheme members who ceased active membership on or after 1 April 2008 and before 1 April 2014

#### 2.11 What is the Discretion being considered:

Whether to grant applications for the early payment of deferred pension benefits on or after age 55 and before age 60 [regulation 30(2) of the LGPS (Benefits, Membership and Contributions) Regulations 2007]

### Compass Contract Services (UK) Ltd's policy statement on the circumstances in which it will exercise this discretion:

Only where there is no financial, or operational disadvantage to Compass Contract Services (UK) Ltd, and/or where unforeseen circumstances might result in the employee suffering personal hardship, and taking all factors into account, will a request for early payment of deferred benefits normally be accepted (other than on the grounds of permanent ill-health or compassion), with the approval of the Finance Director for Compass Contract Services UK Ltd. Where there is no cost to Compass Contract Services (UK) Ltd this decision is delegated to Nicholas Corney Pensions Manager.

#### 2.12 What is the Discretion being considered:

Whether, on compassionate grounds, to waive any actuarial reduction that would normally be applied to deferred benefits which are paid before age 65 [regulation 30(5) of the LGPS (Benefits, Membership and Contributions) Regulations 2007]

## <u>Compass Contract Services (UK) Ltd's policy statement on the</u> circumstances in which it will exercise this discretion:

Only where unforeseen circumstances will result in severe and lasting personal hardship, <u>and</u> taking into account the financial impact on Compass Contract Services (UK) Ltd, will a request on compassionate grounds to waive any actuarial reduction that would normally be applied to deferred benefits which are paid before age 65 be accepted. This discretion will be only be exercised with the prior recommendation of the Nicholas Corney Pensions Manager.

#### 2.13 What is the Discretion being considered:

Whether to grant applications for the early payment of a suspended tier 3 ill health pension on or after age 55 and before age 60 [regulation 30A(3) of the LGPS (Benefits, Membership and Contributions) Regulations 2007]

### Compass Contract Services (UK) Ltd's policy statement on the circumstances in which it will exercise this discretion:

Only where there is no financial, or operational disadvantage to Compass Contract Services (UK) Ltd, and/or where unforeseen circumstances might result in the employee suffering personal hardship, and taking all factors into account, will a request for early payment of suspended tier 3 health benefits normally be accepted (other than on the grounds of permanent ill-health or compassion), with the approval, where there will be a cost to Compass Contract Services UK Ltd, of the Finance Director for Compass Contract Services UK Ltd. Where there is no cost to Compass Contract Services (UK) Ltd this decision is delegated to Nicholas Corney Pensions Manager.

#### 2.14 What is the Discretion being considered:

Whether, on compassionate grounds, to waive any actuarial reduction that would normally be applied to any suspended tier 3 ill health pension benefits which are paid before age 65 [regulation 30A(5) of the LGPS (Benefits, Membership and Contributions) Regulations 2007]

### <u>Compass Contract Services (UK) Ltd's policy statement on the</u> circumstances in which it will exercise this discretion:

Only where unforeseen circumstances will result in severe and lasting personal hardship, <u>and</u> taking into account the financial impact on Compass Contract Services (UK) Ltd, will a request on compassionate grounds to waive any actuarial reduction that would normally be applied to a suspended tier 3 ill health pension benefits which are paid before age 65 be accepted. This discretion will be only be exercised with the prior recommendation of Nicholas Corney Pensions Manager.

#### 2.15 What is the Discretion being considered:

Whether, within 6 months of the date of termination, to augment membership (by up to 10 years) in the pension scheme to a Scheme member whose employment was terminated before 1 April 2014 on the grounds of redundancy or business efficiency [regulation 12 of the LGPS (Benefits, Membership and Contributions) Regulations 2007 and regulation 3(10) of the LGPS (Transitional Provisions, Savings and Amendment) Regulations 2014]<sup>7</sup>

### <u>Compass Contract Services (UK) Ltd's policy statement on the</u> circumstances in which it will exercise this discretion:

Where there is a clear and significant financial or operational advantage to be gained by Compass Contract Services (UK) Ltd, Compass Contract Services (UK) Ltd will consider awarding extra membership in the pension scheme, and only then with the prior recommendation of Nicholas Corney Pensions Manager.

## 3. Discretions for Scheme members who ceased active membership between 1 April 1998 and 31 March 2008

#### 3.1.1 What is the Discretion being considered:

Whether to grant applications for an early payment of pension benefits on or after age 50<sup>8</sup> and before age 60 [regulation 31(2) of the LGPS Regulations 1997]

### Compass Contract Services (UK) Ltd's policy statement on the circumstances in which it will exercise this discretion:

Only where there is no financial, or operational disadvantage to Compass Contract Services (UK) Ltd, and/or where unforeseen circumstances might result in the employee suffering personal hardship, and taking all factors into account, will a request for early payment of deferred benefits normally be accepted (other than on the grounds of permanent ill-health or compassion), with the approval of, where there will be any cost to Compass Contract Services (UK) Ltd, the Finance Director of Compass Contract Services (UK) Ltd. Where there is no cost to Compass Contract Services (UK) Ltd this decision is delegated to Nicholas Corney Pensions Manager.

#### 3.2 What is the Discretion being considered:

Whether, on compassionate grounds, to waive the actuarial reduction that would normally be applied to benefits which are paid before age 65 [regulation 31(5) of the LGPS Regulations 1997]

### Compass Contract Services (UK) Ltd's policy statement on the circumstances in which it will exercise this discretion:

Only where unforeseen circumstances will result in severe and lasting personal hardship, <u>and</u> taking into account the financial impact on Compass Contract Services (UK) Ltd, will a request on compassionate grounds to waive any actuarial reduction that would normally be applied to deferred benefits which are paid before age 65 be accepted. This discretion will be only be exercised with the prior recommendation of Nicholas Corney Pensions Manager.

# 4. Discretions for Scheme members who ceased active membership before 1 April 1998

#### 4.1 What is the Discretion being considered:

Whether to grant applications for an early payment of pension benefits on or after age 50° and before age 60 on compassionate grounds [regulation D11 (2) (c) of the LGPS Regulations 1995]

### <u>Compass Contract Services (UK) Ltd's policy statement on the</u> circumstances in which it will exercise this discretion:

Only where there is no financial, or operational disadvantage to Compass Contract Services (UK) Ltd, and/or where unforeseen circumstances might result in the employee suffering personal hardship, and taking all factors into account, will a request for early payment of deferred benefits normally be accepted (other than on the grounds of permanent ill-health or compassion), with the approval of, where there will be any cost to Compass Contract Services (UK) Ltd, the Finance Director of Compass Contract Services (UK) Ltd. Where there is no cost to Compass Contract Services (UK) Ltd this decision is delegated to Nicholas Corney Pensions Manager.

### **Appendix**

1. Compass Contract Service

 Compass Contract Services (UK) Ltd's Internal Dispute Resolution Procedure

1.1 If a member is not satisfied with any decision made in relation to the Local Government Pension Scheme, they have the right to ask for that decision to be looked at again under a formal complaint procedure. The complaint procedure's official name is the "internal dispute resolution procedure".

The formal complaint procedure has two stages. Many complaints are resolved at the first stage. Any complaint made should be treated seriously, and considered thoroughly and fairly.

A member may ask someone to take their complaint forward on their behalf. This could be, for instance, a trade union official, welfare officer, a spouse or partner, or a friend.

No charge is made at any stage for investigating a complaint under the internal dispute resolution procedure. But expenses that a member will have to meet are their own (and/or their representative's) time, stationery and postage.

#### 1.2 First stage

If a member needs to make a formal complaint, it should be in writing, normally within 6 months of the day when they are told of the decision they want to complain about, and it should be directed to:

The complaint will be considered carefully by the adjudicator who is required to give a decision in writing. If the adjudicator finds in favour of the member, the body that made the original decision about which the member made the complaint will be required to reconsider their decision.

#### 1.3 Second Stage

The member can ask the pension scheme administering authority to take a fresh look at your complaint in any of the following circumstances:

- they are not satisfied with the adjudicator's first-stage decision,
- they have not received a decision or an interim letter from the adjudicator, and it is 3 months since they lodged their complaint,
- it is one month after the date by which the adjudicator told them (in an interim letter) that they would give them a decision, and they have still not received that decision.

This review would be undertaken by a person not involved in the first stage decision. The member will need to send their complaint in writing to the pension scheme administering authority:

within 6 months of the date of the adjudicator's decision, or

- within 9 months from the date they submitted their complaint if the adjudicator has not given them a decision within 3 months of the date they originally submitted their complaint, or
- if the adjudicator gives them an interim decision but not a final decision, within 7 months of the date the adjudicator had promised to give them a final decision.
- 1.4 The administering authority will consider the complaint and give their decision in writing. If the member is still unhappy following the administering authority's second stage decision, they can take their case to the Pensions Ombudsman provided they do so within 3 years from the date of the original decision (or lack of a decision) about which they had complained.
