



Local Government Pension Scheme - Election to re-join the main section

What's the main section of the LGPS?

There are two sections in the LGPS from 1 April 2014 – the main section and the 50/50 section. The main section is where you pay normal contributions and get your normal pension build up. In the 50/50 section you pay half your normal contributions and build up half your normal pension during the time you are in that section. Regardless of which section you're in, you get full life assurance cover, full ill health cover and full survivor benefits in the event of your death.

You can choose to move from the 50/50 section to the main section at any time. A form to re-join the main section must be filled in and sent to your employer. You'll be moved to the main section from the next available pay period after your employer receives your signed form.

If you've more than one job in which you're in the 50/50 section, you can choose to re-join the main section in one, some or all these jobs.

How long can I stay in the main section of the LGPS?

You can stay in the main section for as long as you're in a job that offers you membership of the LGPS and are under age 75.

At any time whilst you're in the main section, you can move back in to the 50/50 section of the scheme (if you're under age 75 and you're still in a job offering you membership of the scheme).

Returning the form

Once you've filled in this form, you must send it to your employer's payroll section or HR department – not the pensions team.

If the form isn't fully complete, or you don't give enough information for your employer to identify the job(s) in which you wish to re-join the main section, the form won't be accepted and will be returned to you to fill in the missing information.

What will this form be used for?

This form, once filled in and returned to your employer's payroll section or HR department, will be used to stop your membership of the 50/50 section of Local Government Pension Scheme, and start deductions of your normal, full, pension contributions as per your instructions on this form. The form will be kept as a record of your decision to re-join the main section of the LGPS, or if you hold more than one job with us, as a record of your decision to re-join the main section in the job or jobs you have indicated on the form.

Automatic enrolment

To meet the automatic enrolment rules of the Pensions Act 2008, your employer must automatically bring you back into the main section of the LGPS every three years. You can choose to re-join the 50/50 section again at that time.

Data protection

The Shropshire County Pension Fund is a data controller under data protection law. This means we store, hold and manage your personal data in line with statutory requirements to enable us to provide you with pension administration services. To enable us to carry out our statutory duty, we are required to share your information with certain bodies but will only do so in limited circumstances.
